EXHIBIT

1. Transportation Expenses
 - 1.1. The allowance for business use of a Trustee's or staff member's car shall be at the rate allowable as travel expenses under the Income Tax Act.
 - 1.2. When travel is by public transportation, actual cost will be reimbursed when supported by suitable receipts. Such costs would include Air Fare (economy rates), bus fare, taxi and/or parking costs.
2. Accommodation Expenses
 - 2.1. Hotel or motel accommodation expenses, including business telephone calls, will be paid at actual cost when supported by suitable receipts. Reasonable hotel gratuities may also be claimed. Personal telephone calls or entertainment costs shall not be considered a reimbursable expense.
3. Meal Allowances
 - 3.1. Meal allowances, which includes gratuities, shall be paid without receipts as follows:
 - 3.1.1. \$15.00 for breakfast,
 - 3.1.2. \$15.00 for lunch,
 - 3.1.3. \$30.00 for dinner,
 - 3.1.4. \$60.00 per full day

If a meal is provided either by a business host, or included in the registration fee, the corresponding meal(s) shall not be claimed. Hospitality costs for specified guests may be included.
4. Economical Choice – All personnel will exercise reasonable judgment in choosing means of transportation and accommodation which reflects concern for the School Division's budget.

Where there are several staff members attending the same function, efforts shall be made, whenever possible, to have two or more members travel in the same car.
